ORDINANCE NO. 2017-05

AN ORDINANCE OF THE BOARD OF SUPERVISORS OF WEST HANOVER TOWNSHIP, DAUPHIN COUNTY, PENNSYLVANIA, AMENDING ARTICLE V, SECTION 187-38 TOW AWAY ZONES DESIGNATED. BE IT ENACTED AND ORDAINED BY THE BOARD OF SUPERVISORS OF WEST HANOVER TOWNSHIP, DAUPHIN COUNTY, PENNSYLVANIA, AND IT IS HEREBY ENACTED AND ORDAINED BY THE AUTHORITY OF THE SAME AS FOLLOWS:

Chapter 187: VEHICLES AND TRAFFIC

Article V. Removal and Impoundment of Illegally Parked Vehicles

§ 187-36. Statutory authority; applicability and scope.

This part is enacted under authority of §6109(a)(22) of the Vehicle Code, *Editors Note: See 75 Pa.C.S.A. §6109(a)(22* and gives authority to the Township of West Hanover to remove and impound those vehicles which are parked in a tow-away zone and in violation of parking regulations of this chapter. Vehicles which have been abandoned (as defined by the Vehicle Code) or which are parked in such a manner as to interfere with traffic or pose a hazard to others may be towed under the provisions of the Pennsylvania Motor Vehicle Code.

§ 187-37. Authority to remove and impound.

The township shall have authority to remove and impound or to order the removal and impounding of any vehicle parked overtime or otherwise illegally, provided that the circumstances of its parking were within the conditions stated in §of this article, and further provided that no such vehicle shall be removed or impounded except in strict adherence to the provisions of this article or the provisions of the Pennsylvania Vehicle Code.

§ 187-38. Tow-away zones designated.

The following designated streets and/or parking lots are hereby established as tow-away zones. Signs shall be posted to place the public on notice that their vehicles may be owed for violation of the township parking regulations
