RESOLUTION by the Board of Supervisors of West Hanover Township, Dauphin County, Pennsylvania establishing the meeting dates for all Boards and Commissions serving the community.

NOW, THEREFORE, BE IT RESOLVED, that the West Hanover Township Board of Supervisors will meet to conduct Township business on the first and third Mondays of each month in 2018 and on Monday, January 7, 2019, at 7:00 PM. A public workshop period is scheduled for the first and third Mondays of each month from 6:00 PM to 7:00 PM on an as-needed basis. Meeting dates that fall on legal holidays observed by the Township have been scheduled to Tuesdays as follows: January 16, 2018, February 20, 2018, and September 4, 2018.

BE IT FURTHER RESOLVED, that, unless otherwise advertised in a newspaper of general circulation in the Township, the following meeting times are established for the boards and commissions of West Hanover Township. All meetings will be held in the West Hanover Township Municipal Building, 7171 Allentown Blvd., Harrisburg, PA 17112, unless otherwise noted.

1. The elected Auditors will meet on Wednesday, January 3, 2017, at 5:30 PM.
2. The West Hanover Township Environmental Advisory Council will meet on the second Tuesday of each month at 6:30 PM.
3. The West Hanover Township Parks and Recreation Board will meet on the third Wednesday of each month at 7:00 PM. Public workshop meetings for the Parks and Recreation Board will be held on the third Wednesday of each month from 6:00 PM to 7:00 PM on an as needed basis. All meetings are held at the Recreation Center at 628 Walnut Ave.
4. The West Hanover Township Planning Commission will meet at 7:00PM on the fourth Thursday of each month, except November and December when it will be the third Thursday of the month. Workshop meetings for the Planning Commission are scheduled for the second Wednesday of each month on an as needed basis.
5. The West Hanover Township Public Safety Advisory Board will meet on the first Thursday of each month at 6:30 PM. All meetings are held at Fire Station #1, 7624 Jonestown Road.

6. The West Hanover Township Water and Sewer Authority will meet at 6:00 PM on the third Tuesday of each. All meetings are held at the Authority office at 7901 Jonestown Road.
7. The West Hanover Township Zoning Hearing Board will meet on the second Thursday of each month on an as needed basis at 6:30 PM.
