ORDINANCE NO. 2018-06

AN ORDINANCE OF THE BOARD OF SUPERVISORS OF WEST HANOVER TOWNSHIP, DAUPHIN COUNTY, PENNSYLVANIA, CHANGING CERTAIN SECTIONS OF CHAPTER 173 OF THE CODE OF WEST HANOVER TOWNSHIP. BE IT ENACTED AND ORDAINED BY THE BOARD OF SUPERVISORS OF WEST HANOVER TOWNSHIP, DAUPHIN COUNTY, PENNSYLVANIA, AND IT IS HEREBY ENACTED AND ORDAINED BY THE AUTHORITY OF THE SAME AS FOLLOWS:

Section 1. The following amendments are hereby added to the West Hanover Township Code of Ordinances:

**ADD Bold – New Language, ~~deleted text~~**

§ 173-37. H. (1) and (3) Use of fee-in-lieu of public park and recreation land dedication.

(1) Acquisition of land and development of facilities at a centralized "community-wide park" as recommended in the Comprehensive Recreation, Park and Open Space Plan of 2000, **as amended**, provided that the development is within the borders of the Township.

(2) Acquisition of land and development of facilities for a "community-wide ped/path system" as planned in the West Hanover Township Ped/Path Plan, **as amended**, provided that the development is within a three-mile radius of the ped/path system.

(3) Acquisition of land and development of existing facilities within a "neighborhood park" as recommended by West Hanover Comprehensive Recreation, Park and Open Space Plan of 2000, **as amended**, provided that the development is within three miles from the neighborhood park.

§ 173-13. B (3) Preliminary Plan - Driveway Profile Scale

B. (3). If applicable, a separate drawing (~~minimum scale one inch equals 10 feet~~) (**1" = 50' horizontal and 1" = 5' vertical**) titled "Driveway Profile," depicting the driveway profile, drainage conditions and entry to the street.

§ 173-15. B (3) Final Plan - Driveway Profile Scale

B. (3). If applicable, a separate drawing (~~minimum scale one inch equals 10 feet~~) (**1" = 50' horizontal and 1" = 5' vertical**) titled "Driveway Profile," depicting the driveway profile, drainage conditions and entry to the street.

Section 2. Saving Clause.


Section 3. Date of Effect.
