A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE TOWNSHIP OF WEST HANOVER, Dauphin County, Pennsylvania (hereinafter "the Township") adopting the Act 537 Special Study.

WHEREAS, Section 5 of the Act of January 24, 1966, P.L. 1535, No. 537, known as the "Pennsylvania Sewage Facilities Act," as amended, and the Rules and Regulations of the Department of Environmental Protection (hereinafter "Department") adopted thereunder, Chapter 71 of Title 25 of the Pennsylvania Code, requires the Township to adopt an Official Sewage Facilities Plan providing for sewage services adequate to prevent contamination of waters and/or environmental health hazards with sewage wastes, and to revise said plan whenever it is necessary to meet the sewage disposal needs of the Township, and

WHEREAS, the Township adopted an Official Act 537 Sewage Facilities Plan Update on August 21, 2006 which evaluated wastewater disposal needs for all of West Hanover Township and provided recommendations for implementation by the Township and the West Hanover Township Water and Sewer Authority, and

WHEREAS, the Township has prepared an Act 537 Special Study for Providing Public Sewer to the Houck Manor and Holiday Park Developments (hereinafter "Special Study") which identifies the preferred methods of extending the public sewer system to serve Houck Manor and Holiday Park and shall serve as a supplement to the Township's 2006 Official Act 537 Sewage Facilities Plan Update, and

WHEREAS, the alternatives of choice to be implemented by the Township and the West Hanover Township Water and Sewer Authority are the construction of a low pressure system to serve Houck Manor and a gravity system and pumping station to serve Holiday Park. The improvements to be undertaken for the alternatives of choice are described in the Special Study, and


WHEREAS, the Township finds that the Special Study described above conforms to applicable zoning, subdivision, other municipal ordinances and plans and to a comprehensive program of pollution control and water quality management.

NOW, THEREFORE BE IT RESOLVED that the Board of Supervisors of West Hanover Township, Dauphin County, Pennsylvania, hereby adopt and submit to the Department of Environmental Protection for its approval as a supplement to the 2006 Official Act 537 Sewage Facilities Plan Update of the Township, the above referenced Special Study. The Township hereby assures the Department of the complete and timely implementation of the said Special Study as required by law (Section 5, Pennsylvania Sewage Facilities Act as amended).
