5. Public Hearing 7:15 p.m. Ordinance 2020-4.

 - c. ***Motion: Mr. Megonnell moved, seconded by Mrs. Zimmerman to approve the vouchers prepaid via check in the amount of \$5,888.86 for Fire Tax. The motion was unanimous.***

10. **New Business**
 - a. 2020 Tire Recycling Project Request – This proposal comes from the Environmental Advisory Council. Mr. Megonnell said the last time the Township collected tires for recycling was in 2017 with the Boy Scouts help. Mr. Miller, Ms. Connors and Mr. Steinmeier all agreed that it was a great
