ORDINANCE NO. 2020-4

AN ORDINANCE OF THE BOARD OF SUPERVISORS OF WEST HANOVER TOWNSHIP, DAUPHIN COUNTY, PENNSYLVANIA, AMENDING CERTAIN SECTIONS OF CHAPTER 195 OF THE CODE OF WEST HANOVER TOWNSHIP. BE IT ENACTED AND ORDAINED BY THE BOARD OF SUPERVISORS OF WEST HANOVER TOWNSHIP, DAUPHIN COUNTY, PENNSYLVANIA, AND IT IS HEREBY ENACTED AND ORDAINED BY THE AUTHORITY OF THE SAME AS FOLLOWS:

Section 1. The following amendments are hereby added to the West Hanover Township Code of Ordinances:

§ ~~195-150.U. 73..U.~~ Temporary signs.

(2) Trailer signs.

- (a) Trailer signs shall only be displayed for a period not greater than 30 consecutive days.
- (b) Trailer signs may be displayed for a period not to exceed 90 days within a calendar year.
- (c) A zoning permit shall be issued for each thirty-day period.

(3) Banner signs or pennants.

- (a) Banner signs or pennants shall be displayed for a period not to exceed 30 days for special events such as grand openings, promotions, etc.
- (b) A zoning permit shall be issued for each thirty-day period.
- (c) Banner signs or pennants may be displayed for a period not to exceed 90 days in a calendar year.

(4) Flag signs.

- (a) Flag signs that are not permanently installed shall be displayed for a period not to exceed 30 days for special events such as grand openings, promotions, etc.
- (b) Flag signs may be displayed for a period not to exceed ~~30~~ 90 days in a calendar year.
- (c) A zoning permit shall be issued for each thirty-day period.

(5) Search lights.

- (a) Search lights shall only be displayed for a period not greater than 24 consecutive hours.

(b) Search lights may be displayed for a period not to exceed 72 hours within a calendar year.

(c) A zoning permit shall be issued for each twenty-four-hour period.

(6) Portable signs.

(a) Portable signs shall only be displayed whenever the use is open for business.

(b) A zoning permit shall be issued. A fee is not required.

Section 2. Saving Clause.



Section 3. Date of Effect.

That the Secretary of West Hanover Township shall certify to the adoption of this Ordinance and cause the same to be published as required by law; and this Ordinance shall take full force and effect immediately upon final passage and approval.
