

NOTICE IS HEREBY GIVEN that the Board of Supervisors of West Hanover Township, Dauphin County, Pennsylvania, intends to consider for adoption and to vote upon enactment of an Ordinance summarized hereinafter at its special meeting to be held on April 12, 2021, at 7:00 p.m., prevailing time. In accordance with Act 15 of 2020, this meeting will be conducted virtually via Zoom video conferencing software. ORDINANCE NO. 2021 -

AN ORDINANCE AUTHORIZING AND APPROVING INCURRENCE OF LEASE RENTAL DEBT THROUGH THE ISSUANCE OF A GUARANTEED REVENUE NOTE IN THE PRINCIPAL AMOUNT OF TWO MILLION FIVE HUNDRED THOUSAND DOLLARS (\$2,500,000.00) (THE "NOTE") BY THE WEST HANOVER TOWNSHIP WATER AND SEWER AUTHORITY (THE "AUTHORITY") AND A GUARANTY AGREEMENT SECURING AND GUARANTEEING THE NOTE BY WEST HANOVER TOWNSHIP (THE "TOWNSHIP") IN A PRINCIPAL AMOUNT NOT TO EXCEED \$2,500,000, AT PRIVATE SALE TO WEST HANOVER TOWNSHIP, FOR THE PURPOSE OF THE AUTHORITY REFUNDING ITS SERIES OF 2012 BONDS AND PAYING THE COSTS OF ISSUANCE OF THE OBLIGATION AND THE GUARANTY; AUTHORIZING AND DIRECTING APPROPRIATE OFFICERS OF THIS TOWNSHIP TO EXECUTE, TO ATTEST, AND TO DELIVER, AS APPROPRIATE, A GUARANTY AGREEMENT, BETWEEN THIS TOWNSHIP, AS GUARANTOR, THE WEST HANOVER TOWNSHIP WATER AND SEWER AUTHORITY, AS BORROWER, AND WEST HANOVER TOWNSHIP AS PURCHASER; APPROVING THE FORM, MAXIMUM GUARANTEED AMOUNTS AND SOURCES OF PAYMENT OF SAID GUARANTY AGREEMENT, SECURED BY THE GENERAL REVENUES OF THE TOWNSHIP AND PLEDGING THE FULL FAITH, CREDIT, AND TAXING POWER OF THIS TOWNSHIP IN SUPPORT THEREOF; PROVIDING FOR PROPER OFFICERS OF THIS TOWNSHIP TO TAKE ALL OTHER REQUIRED, NECESSARY OR DESIRABLE RELATED ACTION IN CONNECTION WITH SAID GUARANTY AGREEMENT; TO OBTAIN THE APPROVAL OF THE DEPARTMENT OF COMMUNITY AND ECONOMIC DEVELOPMENT PURSUANT TO THE PENNSYLVANIA LOCAL GOVERNMENT UNIT DEBT ACT RELATING TO THE GUARANTY, INCLUDING SUBMISSIONS TO EXCLUDE THE DEBT AS SELF-LIQUIDATING AND TO TAKE SUCH FURTHER ACTION AS IS NECESSARY TO EFFECT THE FOREGOING PURPOSES; PROVIDING FOR REPEAL OF ALL INCONSISTENT ORDINANCES OR PARTS OF ORDINANCES; AND PROVIDING WHEN THIS ORDINANCE SHALL BECOME EFFECTIVE.
