RESOLUTION NO. 2022-35

A RESOLUTION BY THE BOARD OF SUPERVISORS OF WEST HANOVER TOWNSHIP, DAUPHIN COUNTY, PENNSYLVANIA, FILING A FORMAL APPLICATION AND BUSINESS PLAN FOR A REDEVELOPMENT ASSISTANCE CAPITAL PROGRAM GRANT IN THE AMOUNT OF ONE MILLION DOLLARS (\$1,000,000.00) FOR SITE WORK, LANDSCAPING, AND ENGINEERING FEES AND PERMITS FOR THE WEST HANOVER TOWNSHIP MUNICIPAL COMPLEX PROJECT IN THE COUNTY OF DAUPHIN.

WHEREAS, the Township of West Hanover (Township), serving as the applicant and grantee, submitted an E-RACP application to the Redevelopment Assistance Capital Program (RACP) requesting funding from the Commonwealth of Pennsylvania (Commonwealth) to support the development of the West Hanover Township Municipal Complex Project (Project) in the Township of West Hanover, Dauphin County; and

WHEREAS, the Township received official notification from the Commonwealth on December 6, 2021 that the Township had been issued a release of One Million Dollars (\$1,000,000.00) in RACP grant funding to be used toward site work, landscaping, and engineering fees and permits needed to facilitate the Project; and

WHEREAS, the Township desires to utilize the RACP grant funds and to take the necessary and/or desirable steps to designate the appropriate staff and officials authorized and directed to take any and all actions necessary to apply, obtain, and effectuate the receipt of the RACP grant funds; and

WHEREAS, the RACP Application and Business Plan (Application) for the RACP grant funds requires a resolution enacted by the Township authorizing the filing of the Application, describing the Project, and identifying the grant amount.

NOW THEREFORE BE IT RESOLVED, by the Supervisors of the Township, of West Hanover Township, Dauphin County, Pennsylvania, as follows:

1. The foregoing recitals are incorporated herein and made an essential part hereof, as though fully set forth herein.
2. The Township supports the RACP grant funding in the amount of One Million Dollars (\$1,000,000.00) to be used to advance the Project.

3. The Township agrees to serve as the applicant and grantee for the RACP Business Plan and Application and to receive RACP funds for use in effectuating the development of the Project.
4. The Township authorizes the use of internal funds as a source of the RACP Project's interim financing and match financing.
5. The Chairman of the Board of Supervisors and/or the Township Manager is authorized and directed to take any and all actions necessary and/or desirable to effectuate the RACP grant, including, but not limited to the execution and submission of the Application and any other documents necessary and/or desirable to effectuate receipt of the RACP funds.
6. The provisions of this Resolution are declared to be severable, and if any section, subsection, sentence, clause or part thereof is, for any reason, held to be invalid, unlawful or unconstitutional, by a court of competent jurisdiction, such decision shall not affect the validity of any remaining sections, subsections, sentences, clauses, or part of this Resolution.
7. This Resolution shall take effect immediately upon its passage and adoption.
8. All other resolutions or parts of resolutions inconsistent herewith are hereby repealed.
