RESOLUTION NO. 2022-39

**A RESOLUTION OF WEST HANOVER TOWNSHIP, DAUPHIN
COUNTY, PENNSYLVANIA, AUTHORIZING A JOINT COST SHARING
AGREEMENT WITH VARIOUS INTERESTED MUNICIPALITIES
REGARDING THE CHALLENGE TO THE I-83 SOUTH BRIDGE
PROJECT**

WHEREAS, West Hanover Township, Dauphin County, Pennsylvania (the “Township”) is a political subdivision of the Commonwealth of Pennsylvania, governed by Pennsylvania’s Second Class Township Code, 53 P.S. § 65101, *et seq.*; and

WHEREAS, pursuant to the Pennsylvania Intergovernmental Cooperation Act, 53 Pa.C.S. § 2301, *et seq.*, local governments may enter into intergovernmental cooperation agreements with another governmental unit or local government in the exercise or in the performance of their respective governmental functions, powers, or responsibilities, upon the passage of an ordinance or resolution by its governing body; and

WHEREAS, the Second Class Township Code empowers the Board of Supervisors of the Township, as its governing body, to enact, revise, repeal, and amend ordinances and resolutions, not inconsistent with the laws of the Commonwealth, as it deems beneficial and to provide for enforcement of the same; and

WHEREAS, the proposed Joint Cost Sharing Agreement relating to the challenge of the I-83 South Bridge Project, attached hereto as Exhibit “A” and incorporated herein by reference, is among and between the Township, Camp Hill Borough, Lemoyne Borough, New Cumberland Borough, Wormleysburg Borough, and East Pennsboro Township and qualifies as an intergovernmental cooperation agreement in the performance of their governmental functions, powers, and responsibilities; and

WHEREAS, the Board of Supervisors deems it beneficial to the Township and desires to implement and utilize the Joint Cost Sharing Agreement.

NOW THEREFORE, BE IT RESOLVED, by the Board of Supervisors of West Hanover Township, Dauphin County, Pennsylvania as follows:

Section 1. The above recitals are incorporated herein by reference hereto.

Section 2. The Board of Supervisors is hereby authorized to enter into the Joint Cost Sharing Agreement with Camp Hill Borough, Lemoyne Borough, New Cumberland Borough, Wormleysburg Borough, and East Pennsboro Township and any other interested municipal subdivisions that may later join, subject to the terms stated therein. The specific terms, conditions, and provisions of the Joint Cost Sharing Agreement are made a part of this Resolution.

Section 3. The provisions of this Resolution shall be severable, and if any of its provisions shall be held unconstitutional, illegal, or invalid, such unconstitutionality, illegality, or invalidity shall not affect the validity of any of the remaining provisions of this resolution.

Section 4. All resolutions, or parts thereof, insofar as they are inconsistent herewith, shall be hereby repealed.

Section 5. This Resolution shall become effective immediately.
